**Temporary declaration of cost-coverage (befristete Kostenübernahmeerklärung) in favour of the service providers (including flights) regarding the services contractually agreed between JT Touristik GmbH and the respective service providers for the travelers of JT Touristik GmbH with the date of departure until 31.10.2017**

Dear Mrs. Taylor, Dear supplier,

JT Touristik GmbH has filed for bankruptcy.

JT Touristik GmbH currently has the legally required customer protection insurance (*Kundengeldabsicherungsvertrag*) according to Sec 651k German Civil Code with Generali Versicherung AG. All rights under the customer protection insurance are reserved as a precaution.

"REISEGARANT" is the underwriting agent and the settlement agency for the customer guarantee of Generali Versicherung AG.

In the name and by power of attorney of Generali Versicherung AG, we hereby confirm in favour of all service providers (but not in favour of JT Touristik GmbH) that all costs for the suppliers (including flight reservations) contractually agreed between JT Touristik GmbH and the respective suppliers for travellers, which have already booked journeys with JT Touristik GmbH, will be covered by Generali Versicherung AG to the full extent in accordance with this temporary declaration of cost-coverage (*befristete Kostenübernahmeerklärung*).

This temporary declaration of cost-coverage (*befristete Kostenübernahmeerklärung*) in favour of the suppliers applies only to:

1. Travelers who are currently booked in the hotels with JT Touristik GmbH, from 29 September 2017 (inclusive) to the end of the booked journey, without prejudice to point 3 of this temporary declaration of cost-coverage.



2. Travelers, starting their booked journey to the booked destination from 29 September 2017 (inclusive) to the end of the journey booked at JT Touristik GmbH, whereby point 3 of this temporary declaration of costs shall remain unaffected.
3. This temporary declaration of cost-coverage applies only to all journeys of JT Touristik GmbH with the date of departure from Germany until 31.10.2017.

Please ensure that all customers of JT Touristik GmbH are treated equally and that no hotel or transfer service provider will have the travellers pay locally.

This declaration also covers hotel only bookings when booked under the terms and conditions of JT Touristik GmbH.

All receivables / costs incurred by suppliers prior to 29 September 2017 are **not** covered by this temporary declaration of cost-coverage. Insofar as JT Touristik has already made advance payments for the services to be rendered, we assume that any advance payments will be credited accordingly and that JT Touristik GmbH will monitor this.

This declaration of costs against the beneficiaries is limited for travellers starting their journey until 31.10.2017 and does not extend automatically.

For purposes of clarification only, we point out that JT Touristik GmbH does not acquire or derive any claims or rights against Generali Versicherung AG from this temporary declaration of cost-coverage. Conversely, the assertion of (recourse) claims of Generali Versicherung AG against JT Touristik GmbH is reserved as a precaution.
